On O4 Nov 88 unknown landmines planted by RENAMO bandits were discovered around Mtipa and Munguluwe. The areas in question were once attacked by RENAMO bandits and a good number of villagers had deserted and stayed in the bush for fear of attacks.

On O4 Nov 88, ten (10) suspected RENAMO bandits, six (06) of them armed with rifles and four (04) with axes attacked and destroyed Mr Sanikonda PHIRI's grinding mill and stole six (06) blankets and also looted Mr MVULA's home.

On 05 Nov 88, 43 Mozambicans were apprehended by own soldiers from VUBWI after being suspected to be RENAMO bandits.

On 14 Nov 88 at approximately 0300 hours, Headman of Chinandi village Mr Yepulani BANDA and his wife Elizabeth PHIRI BANDA were axed to death by RENAMO bandits and the same MNR proceeded and looted a shop belonging to Mr MWALE about 4km South East of Kagoro and got away with goods worth about K30,000.00

106. 16/11/88

On 16 Nov 88 at about 2213 hours
RENAMO bandits attacked Chikunkula
village, Chief Mwanjawanthu - Petauke
and took a total of 38 cattle.

107. 18/11/88

On 18 Nov 88, at about 1000 hours

Mr Phillip BANDA and his wife were abducted
by MNR bandits whilst ploughing in their
field at Chinkomo village in Petauke

District. Mrs BANDA was released on the
same day and given a note by MNR which

weapons failure to which Mr BANDA would
