SUBJECT: FRELIMO PARDONS 240 "TRAITORS"

1. SUMMARY: FRELIMO MARCH 16 PARDONED JLRP "TRAITORS",
INCLUDING URIA SIMANGO AND PAULO GUMANE, AFTER PRINCIPAL
MEMBERS OF GROUP READ ABJECT CONFESSIONS BEFORE MASS
RALLY AT FRELIMO'S NACHINGWEA CAMP. GUMANE SOUGHT IMPLICATE
US, ISRAEL AND OTHERS AS HAVING GIVEN HIM ADVICE AND FINAN-
CIAL SUPPORT, AND HIS CONFESSION SINGLED OUT A NUMBER
OF AMERICAN DIPLOMATS BY NAME. ALTOGETHER IT WAS A
DEGRADING SPECTACLE REMINISCENT OF THE SOVEIT PURGE
TRIALS. END SUMMARY.

LEADERS DRAMATICALLY PARDONED 240 "TRAITORS", ALL AFRICAN
MOZAMBICANS. ROSTER SO FAR MENTIONED IN PRESS INCLUDES:
PAULO GUMANE (EX-HEAD OF COREMO),
FAUSTIN KAMBEU (EXECUTIVE
SECRETARY OF COREMO),
ASSAHEL JOHASSANE MAZULA (EX-MEMBER MOZAMBIQUE
LEGISLATIVE COUNCIL),
REV. URIA SIMANGO (ONE TIME VICE PRESIDENT OF FRELIMO
WHO DEFECTED TO COREMO AND BECAME LATTER'S SECRETARY FOR
FOREIGN AFFAIRS.

LAZARO KAVANDAME (FRELIMO PROVINCIAL SECRETARY FOR
CABO DELGADO WHO DEFECTED TO PROTUGUESE),
JOAO JOSE CRAVEIRINHA (FRELIMO GRAPHICS EXPERT WHO
DEFECTED TO PORTUGAL: SON OF MOZAMBIQUE BUREAUCRAT OF SAME
NAME AND NEPHEW OF POET JOSE JOAO CRAVEIRINHA),
DR. JOAO UNYAI (PARTISAN OF SIMANGO)
BASILIO BANDA (FRELIMO MEMBER WHO DEFECTED TO
PORTUGUESE),
ALI MADEBE (MEMBER OF SO-CALLED "COUNCIL OF ELDERS"
OPPOSITION GROUP WITHIN FRELIMO IN 1968),
VERONICA ANJIVA (ONLY WOMAN IN GROUP; ACCUSED
OF HAVING HARBORED ASSASSINS SEEKING TO KILL MACHEL
IN 1969).



3. CEREMONY, ACCORDING EYE-WITNESS, WAS IMPRESSIVE IF DEGRADING SPECTACLE LASTING SOME SEVEN HOURS. AFTER SMALL FRY PARADED BEFORE CROWD IN GROUPS AND PARDONED, THE SIX MAIN OFFENDERS (THE SIX FIRST MENTIONED ABOVE) WERE REQUIRED TO READ ALOUD LONG AND DETAILED CONFESSIONS OF THEIR CRIMES, CULMINATING IN WHAT MACHEL CALLED HIS "CHRISTMAS TURKEY", URIA SIMANGO. SOME WHO READILY BLACKENED THEMSELVES WERE TREATED FAIRLYKINDLY; OTHERS WHO STILL MAINTAINED SOME INNOCENCE WERE CONFRONTED WITH "NEW EVIDENCE" AND FURTHER REVILED. THUS 63-YEAR OLD KAVANDAME TRIED TO PLEAD INNOCENT TO WORKING FOR PORTUGUESE SECRET POLICE (PIDE) AND AFTER CONFRONTATION WITH SUPPOSED WRITTEN PROOF TO THE CONTRARY WAS COMPELLED TO JOIN WITH CROWD IN SINGING SONG DENOUNCING HIS OWN TREASON. CRAVEIR-INHA ALSO ROUGHLY TREATED, AND FORCED TO CONFESS TO DRUNKEN-ESS AND KEEPING PROSTITUTES. AFTER EACH CONFESSION, THE CONFIDENTIAL

READER WAS TOLD TO ASK CROWD WHAT PUNISHMENT HE DESERVED, WITH CROWD GENERALLYLOUDLY DEMANDING HANGING. HOWEVER, ALL WERE PARDONED, OR AT LEAST REPRIEVED, FOR IT IS NOT CLEAR THAT THEY WILL NOT HAVE TO PERFORM SOME FORM OF FURTHER PENANCE.

4. OF PRINCIPAL CONCERN TO USG WILL BE CONFESSION FROM GUMANE, SEEKING IMPLICATE VARIOUS US DIPLOMATS AS HAVING PROVIDED FINANCING AND ENCOURAGEMENT TO OPPOSE FRELIMO. ACCORDING DAILY NEWS ACCOUNT GUMANE AND OTHERS "ALL ADMITTED TO HAVE CONNECTIONS WITH DIPLOMATS OF THE EMBASSIES OF THE UNITED STATES, ISRAEL, AND SOME CERTAIN AFRICAN COUNTRIES". SWAHILI DAILY UHURU ACCOUNT MORE SPECIFIC, SAYING THAT GUMANE'S CONFESSION"EXPLAINED THE ESPIONAGE OF THE AMERICAN EMBASSIES IN DAR ES SALAAM AND LUSAKA." GUMANE QUOTED AS SAYING THAT HE MET AMERICAN CONSUL JOHN BLACKEN AT THE AMERICAN EMBASSY IN DAR ES SALAAM IN 1962, AND LATTER GAVE HIM MONEY AND ADVISED HIM UNTIL HE MOVED TO LUSAKA IN 1965. SINCE 1962 HE HAD ALSO RECEIVED MONEY FROM ISRAEL AND WESTERN EUROPEAN COUNTRIES. IN LUSAKA HE DEPENDED ENTIRELY ON MONEY PAID HIM BY WESTERN EUROPEAN COUNTRIES. HE WAS ALSO SUPPORTED BY THEN ZAMBIAN VICE PRESIDENT KAPWEPWE, WHO GAVE COREMO MORE THAN 10,000 SHILLINGS AND ADVISED IT TO TRY TO OPPOSE FRELIMO INSIDE MOZAMBIQUE. FINALLY, GUMANE QUOTED AS SAYING THAT AFTER FRELIMO VICTORY LAST YEAR, HE WAS ADVISED BY THE AMERICAN EMBASSY IN LUSAKA (EYEWITNESS SAYS HE SPECIFIED CONSUL CLAGETT TAYLOR) TO RETURN QUICKLY TO MOZAMBIQUE IN ORDER BUILD HIMSELF UP BEFORE S ELIMO SEIZED POWER. TWO AFRICAN AMBASSADORS (EYEWITNESS SAID SWAZILAND DEPUTY PRIME MINISTER



NAMED) ALSO ADVISED HIM TO BUILD UP ANTI-FRELIMO MOVEMENT. (EYEWITNESS SAID GUMANE NAMED OTHER AMERICAN OFFICERS IN ZAMBIA AS CONTACTS.)

5. COMMENT: MODE AND CONTENT OF CONFESSIONS SUGGEST FRELIMO HAS WELL LEARNED TECHNIQUE OF BRAINWASHING FROM ITS CHINESE MENTORS. ABJECT CONFESSIONS, SOUPED UP WITH PLAUSIBLE DETAILS, INCLUDING NOT ONLY EVERY IMAGINABLE POLITICAL CRIME BUT ALSO MORAL TURPITUDE, CONFIDENTIAL

PUBLIC HUMILIATION OF CONFESSION-READERS, DEMANDS FOR THEIR EXECUTION AND MAGNANIMOUS REPRIEVE, ARE ALSO PART OF PATTERN, AS IS THE IRRELEVANT IMPLICATION OF OTHER VILLAINS OF THE MOMENT (SUCH AS ISRAEL). ALTOGETHER A NEITHER PRETTY NOR REASSURING PICTURE OF THE KIND OF GOVERNMENT FRELIMO WILL FORM.

6. GUMANE'S EFFORTS IMPLICATE USG IN HIS ACTIVITIES, OR RATHER FRELIMO'S DECISION TO FEATURE THEM IN HIS CONFESSION, ALSO DISTURBING AT MOMENT WHEN WE AND FRELIMO DISCUSSING POSSIBLE AID PROGRAM (WE UNDERSTAND MACHEL, IN HIS ADDRESS TO RALLY, PUBLICLY SCOFFED AT WESTERN AMBASSADORS WHO NOW RUSHING IN WITH AID OFFERS). WE HOPE TO HAVE MORE ON THIS PARDON SPECTACLE SOON. AT ANY RATE IT SHOULD RELIEVE DOUBTS ABOUT FATE OF SOME FRELIMO OPPONENTS. JOANA SIMIAO WAS NOTABLY ABSENT FROM CEREMONY; WHETHER THIS MEANS SHE STILL AT LARGE OR NOT SUBJECT TO PARDON REMAINS TO BE SEEN.
